ORDER:

In the reference 1st read above, the NCTE, SRC, Bangalore has granted recognition to B.S.Bugudi B.Ed College, Plot No.1, Tandur Village & post Office, Tandur Taluk & City, Ranga Reddy District (now Vikarabad District)-501141, Telangana for conducting B.Ed Programme of (2) years duration, with annual intake of 50 students (1 Unit) from the Academic Sessions 2016-2017, subject to the fulfillment of certain conditions.

2) In the reference 2nd read above, the Director of School Education, Telangana, Hyderabad, was requested to furnish the inspection report along with his remarks, as per the new NCTE Norms and Regulations of 2014, to the Government immediately.

3) In the reference 3rd read above, the Hon'ble High Court in its order dt.10.10.2017 in WP.No.33742/2017 filed by B.S.Bugudi B.Ed College, Ranga Reddy Dist., Telangana has ordered as follows:-

".....In the circumstances, the Writ Petition is disposed of with a direction to respondents to consider the case of the petitioners, in terms of para 20 of the judgment of the learned Single Judge in Writ Petition No.26870 of 2016 and batch, dated.16.9.2016, for the Academic Year 2017-18, and take necessary decision within a

week from the date of receipt of a copy this order.No costs. Consequently, the miscellaneous Applications, if any shall stands closed."

4) In the reference 4th read above, the Commissioner and Director of School Education, Telangana, Hyderabad, has furnished a report in respect of B.S.Bugudi B.Ed College, Ranga Reddy Dist., wherein it was reported that one Faculty Member namely Sri Gudimalla Damodar, Lecturer in Mathematics is duplicated as Lecturer in Mathematics at Sri Aurobindo's D.Ed College, Gaddipally (V), Garidepally (M), Nalgonda District. No faculty member is having (3) years of teaching experience in the institution as per the NCTE norms.

5) In the reference 5th read above, the Government have addressed a letter to the Regional Director , NCTE, SRC, Bangalore to withdraw the recognition to B.S.Bugudi B.Ed College, Ranga Reddy Dist for conducting B.Ed programme of (2) years based on the deficiencies reported by Commissioner and Director of School Education, Hyderabad.

6) In the reference 6th read above, the Regional Director, NCTE, SRC, Bangalore has informed that the Telangana Government letter is considered and based on the deficiencies pointed out by the Telangana Government and the NCTE has issued Show Cause Notice to the Institution viz. B.S.Bugudi B.Ed College, Ranga Reddy Dist., on 28.11.2017 accordingly.

7) In the reference 7th read above, the Hon'ble High Court issued a Show Cause Notice dtd.13.07.2018 in CC No.1633/2018.

8) In the reference 8th read above, the Government have rejected the permission to the B.S.Bugudi B.Ed College, Ranga Reddy Dist.for conducting of B.Ed Programme keeping in view the deficiencies as reported by the Commissioner and Director of School Education, Hyderabad.

9) In the reference 9th read above, the Hon'ble High Court have issued Form-I Notice in Contempt Case No.1633/2018,dtd.14.12.2021.

10) In the reference 10th read above, the Hon'ble High Court in its Interim Order dtd.14.12.2021 in WP No.32599/2021 is as follows:-

"....In the circumstances, there shall be interim direction to respondent Nos. 1 & 4 to include the name of the petitioners - College forthwith in the process of counseling for B.Ed. course for the academic year 2021-22. However, this order shall not preclude the respondent No.s 1 & 6 to conduct a joint inspection of the premises of the petitioners - College to ascertain whether or not the deficiencies pointed out under show-cause notices, dated 28.11.2017 & 11.01.2018 have been rectified by the petitioners - College."

11) Keeping in view of the recognition granted by the National Council for Teacher Education, SRC, Bengaluru, and in compliance of the Hon'ble High Court orders dtd.10.10.2017 in W.P.No.33742/2017, Government hereby permit B.S.Bugudi B.Ed College, Plot No.1, Tandur Village & post Office, Tandur Taluk & City, Ranga Reddy District (now Vikarabad District)-501141 for conducting B.Ed Course of Two years duration, with an annual intake of 50 students (1 unit), subject to the fulfilment of certain conditions, duly withdrawing the orders issued in the reference 8th read above.

12) The Director of School Education, Hyderabad is directed to conduct a joint inspection along with team of the NCTE, SRC, New Delhi of the premises of the B.S.Bugudi B.Ed College, Plot No.1, Tandur Village & post Office, Tandur Taluk & City, Ranga Reddy District (now Vikarabad District) as per the Interim Direction of the Hon'ble High Court, dtd.14.12.2021 in WP.No.32599/2021.


